## **New England Archivists Annual Business Meeting**

#### **Call to Order**

Alyssa Pacy called the meeting to order and welcomed conference attendees to the annual business meeting. She thanked Kelli Bogan and the program committee for the wonderful job.

## **Approval of 2013 Annual Business Meeting minutes**

The Annual Business Meeting minutes of March 23, 2013 were approved.

#### **VOTES**

The following two votes were approved: 1. change to a revolving membership period 2. increase annual dues (from \$30 to \$35 for members, from \$15 to \$17.50 for students, from \$40 to \$45 for institutional).

#### **Treasurer's Report**

Juliana Kuipers presented NEA's financial report for FY 2014 (Jan. to Dec.). Overall, NEA financial status is in good condition with total assets of over \$90,000. NEA has \$15,000 in different restricted funds for Hale and Haas award and she said that there is only enough money for two additional awards. She announced that NEA will be adding a donate button to the web site to make it easier for those who want to donate to these awards. She pointed out that assets went down \$9,000 from last year this is in part due to last year's 40<sup>th</sup> anniversary expenses.

## **Archival Advocacy Award**

Paige Roberts presented Northeast Document Conservation Center (NEDCC) with the Archival Advocacy and Distinguished Award for over 40 years protecting cultural heritage collections.

#### **Distinguished Service Award**

Paige Roberts presented the Distinguished Service Award to Jane Ward for her significant contributions to NEA during the past 26 years.

#### Richard L. Haas Records Management Award

Colin Lukens announced the winner of the 2014 Haas Award. Christina Zamon, Head of Emerson College Archives and Special Collections. Zamon will use the funds to experiment with AToM as both an archives and records management tool configure with Amazon EC2cloud storage support as well as to discover the operability of said configuration with third party solutions such Preservica and Recall. The goal is to explore the possibility of operating an archival description and records management system without having to rely on dedicated IT and archival staff.

## Richard W. Hale, Jr. Professional Development Award

Joanie Gearin announced the winner of the Hale Award for 2014. Eugenia Kim, Digital Archivist at Emerson College Archives and Special Collections. Kim will use the award to attend the joint International Association of Libraries, Museums, Archives and Documentation Centers of the Performing Arts Theater Library Association 2014 meeting. She will establish a web site to document the history of 20<sup>th</sup> c. Boston concert dance.

She said that by understanding membership needs, supporting the exchange of ideas, and building a sustainable organization NEA will stay true to the principles of openness and transparency. She then thanked the attendees for being part of NEA.
